#### Scholarships Benefit

#### Orphan Scholarships Member Benefit

#### Critical Illness Member Benefit

#### Young Family Member Benefit

Ensuring your children are taken care of is one of your most important concerns. This benefit pays \$300 a month per child to the legal guardian for children under 18 years of age in the event of the death of both parents.

#### Terminal Illness Member Benefit

The certificate and/or policy must be absolutely assigned to Foresters to the extent of its interest, up to a maximum of \$250,000. The loan will be repaid from the insurance proceeds payable upon the insured's death.
